Compensation for all officers is determined through a careful process. For the top management official (President), compensation is reviewed and approved by the other members of the Board (i.e. the President is not present for or privy to the conversation). Comparability data was used to determine a range for the compensation, and the Board voted on the final amount, with consideration given to Clover's budget and the need to keep the compensation affordable. For other officers, the compensation is determined using comparability data, and all Board members vote on the amount except the officer for whom compensation is being determined. All voting is kept confidential.
