Concordia Community Support Services (CCSS) manages the leadership and operations of Concordia Visiting Nurses; Alliance Visiting Nurses, dba, VNA Alliance; Good Samaritan Hospice of Pittsburgh; Concordia Hospice of Washington, Concordia Private Care, and Concordia Medical Equipment. All of these entities are 501(c)(3) non-profit entities. During this fiscal year, CCSS entered into a new consulting and then management agreement with VNA of Indiana County that performs home health and hospice services. During the fiscal year, approximately 21,880 patients were served across 15 counties in home health, hospice and private duty services. In addition, Concordia Medical Equipment supports the approximately 40,000 patients that Concordia Lutheran Ministries serves over 12 campuses by providing durable medical equipment and supplies. From nursing and therapy services to specialized services such as IV Therapy, wound care, palliative care and mental health care, our visiting nurses teams ensure that patients are provided care in the comfort of their own home with the goal of preventing rehospitalization and monitoring chronic disease states. Our hospice team provides comfort care to improve the overall quality of life of patients who are on their end-of-life journey. Our medical equipment agency is dedicated to enhancing home safety by providing a wide selection of durable medical equipment and related home medical equipment and supplies such as home accessibility products, mobility aids, and respiratory products and services. Families of our patients play a vital role so we educate and support them through situations related to caring for a loved one who is aging, all the way through their end-of-life. Bereavement care is also provided to families of hospice patients for at least a year beyond the patient's death. Employees are offered training and opportunities to obtain new skills such as Wound Care Certification, Palliative Care Training, IV Therapy Certification, Lymphedema Therapy Certification, Home Health and Hospice Coding Certification, and Hospice Boot Camp Training. Employees are offered an opportunity to attend nursing school tuition-free and two employees took advantage of the offer during the fiscal year. On January 31, 2020, acting HHS Secretary Alex Azar first declared a public health emergency following the World Health Organization's recognition of the novel coronavirus, COVID-19, as a pandemic. In response to this coronavirus outbreak, the state and federal governments have taken preventative or protective actions, such as imposing restrictions on travel and business operations and advising or requiring individuals to limit or forego their time outside of their homes. Daily high-level leadership meetings were established to assess and provide guidance to staff through every changing regulation surrounding the pandemic. Throughout the pandemic, education and guidance related to best practices and CDC protocol was provided by our corporate compliance team. This allowed our frontline workers to remain safe and able to provide quality care to many COVID affected patients and families. Employees were awarded a daily appreciation bonus for each shift worked. Even with decreased census when surrounding hospitals shut down, there were no layoffs as a result of the pandemic. A call center was established to call any current or referred patients even if they were declining visits to ensure there wasn't an exasperation of symptoms to avoid rehospitalizations. The agency worked with a corporate purchasing team to ensure appropriate levels of personal protective equipment (PPE), laboratory equipment, tests and other related COVID response items were purchased to provide care is the safest way possible. Our Director of Communications participates in educational radio shows. The cost of the time invested by our Director of Marketing is just over \$4,000. The goal of these radio shows is to educate family caregivers. During the COVID-19 pandemic, the shows took on a different goal of educating the community about disease control, PPE and the ways that Concordia home and community-based services are handling the pandemic and safely continuing to care for the needs of their patients and families. Some of the topics covered in 2019-2020 include: Preventing Falls Exercise Program, Medicare Open Enrollment Tips for 2020, What is physical therapy?, National Homecare and Hospice Month, Concordia Physician Practice, Generic vs. Brand name drugs, The Coronavirus 2020, COVID-19 education, Social Distancing and TeleCare Givers, Coronavirus Scams, Signs of Osteoporosis, What's in an Alzheimer's test?, WBVP Nonverbal signs of pain with Dementia. In addition to radio shows, our educational websites are helpful to visitors who are in need of family caregiving tips including a wide range of needs from Alzheimer's and memory impairment to common diseases like CHF, COPD and Diabetes. The Palliative care website assists people who struggle with a serious illness but are still seeking curative care. There are two hospice websites, one for the Pittsburgh market and one for the Washington, PA market, which are helpful for people suffering from a serious illness and are needing hospice care. Leadership served at Katie's Kitchen, St. Mark's Lutheran Church in Butler, PA. The kitchen provides a free meal every Thursday. Individuals participate in serving the meal and cleanup afterwards. Several of our CCSS employees and members of management serve annually at Concordia Summer Festival (July 2019) and Concordia Octoberfest (October 2019). Both events are sponsored by Concordia Lutheran Health and Human Care and are open to the public as a way of providing entertainment, food and refreshments and a feeling of community. One CCSS employee in particular devotes an extra 40 hours per year to coordinate the Kids Area for each festival which includes activities, crafts and face painting, all of which are provided free to the public. A Mission Committee was formed by CCSS to organize opportunities for employees to serve the community. The committee consists of employees of CCSS and the six agencies that we manage and the approximate cost of the time invested in the meetings to organize the events is \$5,400. The events completed this year include: In the summer of 2019, CCSS employees partnered with Freeport High School to assist with their Blessings in a Backpack program. This program supplies the families of children on the free lunch program with groceries during the summer months when school is not in session. Our employees worked in teams which picked up groceries from Walmart and filled 20-25 bags with non-perishable items and dropped off the completed bags at the school. There were three food packing days that fell in the fiscal year ending June 30, 2020. A Servant Day/House Build was held on Sept 21, 2019 when employees partnered with St Luke Lutheran Church to construct the frame for a 1,500 square foot house. The team was assisted by the Center for Community Resources from Butler, PA and Crossroads Mission-Help Build Hope from Louisville, KY. Other service opportunities available that day were making fleece blankets for Ronald McDonald House, sewing dresses for girls in Tanzania, making greeting cards for Military families, preparing dry soup mix for local food pantries. An employee of CCSS continued to participate in the Dress A Girl sewing group at St Luke for six months after the Servant Day which is the group that sews dresses for girls in Tanzania. For the Christmas 2019 season, employees received the Christmas wish lists of 24 children through a partnership with Butler County Children and Youth. Employees purchased gifts and wrapping paper to give to the families in the program. The following local organizations have received direct financial support from Concordia Community Support Services through sponsorships of events: BC3 Education Foundation, Inc., Butler Catholic School, Butler County Symphony Association, Butler Health System Foundation, Community Health Center, Concordia Lutheran Ministries Foundation - Charitable Fund, County of Butler Children & Youth Agency, Freeport Football Boosters, Knoch Track & Field Booster Association, Trib Total Media. Total cost to the agency for sponsorships for fiscal year ended 6/30/2020 equated \$3,315. CCSS made cash donations to various other 501(c)(3) organizations including: St Luke Lutheran Church: \$1,974, Good Samaritan Endowment Fund: \$450,030, as well as \$982 in donations related to our Mission Events. Concordia Tele-CareGivers was supported with a total of \$18,000, and Concordia Lutheran Ministries Parent: a total of \$4,050,000. The donations are used to support other non-profits and further the mission of caring for God's people either through charitable care that supports patient's needs or to better serve both domestic and foreign communities through Christ-centered programs.
