The Northwest Regional Adult Drug Treatment Court served 45 individuals in FY19. Thirteen clients successfully completed the program. Thanks to a grant from the United Way of the Northern Shenandoah Valley, the NSVSAC was able to connect certified peer recovery specialists to 344 local residents who are living with addiction. With a powerful message of hope combined with the experience of success in their own recovery, peer recovery specialists serve as life coaches, extending the clinical reach of treatment and going directly into the lives of people who need them most. The peers assist the individuals with creating a Wellness Recovery Action Plan (WRAP) to identify goals and develop a plan to prevent substance use.

During FY19 the Law Enforcement Overdose Intervention Program (LEOIP) served 27 clients. Of the 27 total clients, 19 clients received outpatient treatment three days a week, individual therapy, case management services and peer services. Eight individuals received only peer services through the program. The program is now partnering with District 11 Probation and Parole to receive referrals. The LEOIP treatment team has successfully collaborated with local agencies to create volunteer opportunities to help increase a sense of purpose and productive use of time for clients. In FY19 three community-wide events were held with a total of 488 attendees. The Executive Director of NSVSAC participated in 20 presentations including meeting with officials from the White House Office of National Drug Control Policy.

During this fiscal year the NSVSAC continued the Give Me a Reason Drug Prevention initiative program. Since its implementation 336 kits have been distributed to local parents. This fiscal year the Coalition partnered with local juvenile and domestic relations court judges to utilize the screens and to give them to parents of youth involved in the court system. When the COVID-19 pandemic started in March, the NSVSAC partnered with Winchester Public Schools to provide testing kits at Wifi locations for parents.
