Community Mental Health Taskforce: The hospital participates in this taskforce created to address mental health issues in the county. They meet quarterly to develop resources and educational opportunities to bring awareness and create a dialogue between agencies to better care for mental health patients. Public educational forums are planned each spring and fall. The impact is monitored as activities and initiatives continue to develop over the years. The goal is to educate the communities in McPherson County about mental health issues and to develop inter-agency strategies to provide appropriate care for patients. This taskforce has continued to convene safely during the last year to explore ways to educate and develop strategies, but any progress on specific related activities had to be suspended indefinitely due to the pandemic. Assess Internal Employee Assistance Program and Provide Training: As a means of assisting hospital employees while educating them on mental health issues, the plan is to research available resources and opportunities for hospital employees to become educated about and engaged in the management of their own potential issues as well as issues for patients. Better educated employees will allow for appropriate treatment and care for themselves and their patients. This employee-focused assistance program is promoted during new employee orientation and periodically in monthly staff newsletters to inform and encourage utilization of services for personal well-being in a variety of life situations and circumstances. Statistics for usage are not documented due to confidentiality concerns. Community Drug Abuse Taskforce: The hospital is part of this ongoing taskforce whose goals are to provide resources, outreach and education to the public about the dangers of opioid use. The impact is monitored as activities and initiatives develop over the years. The goal is to educate the communities in McPherson County to help prevent abuse, make McPherson County a safer place, and to get ahead of the epidemic. This group typically meets quarterly but suspended all meetings during the pandemic. They will resume their work when they are able to begin safely meeting together. K-TRACS EHR Integration: This is a database designed to let physicians and pharmacists know if a patient is receiving and filling multiple controlled substance prescriptions. The plan is to integrate patient drug prescribing history into our EHR. Providers who are aware of their current and past prescriptions can make informed decisions on what they are prescribing. A contract has been signed with the software interface management group. We are still working on full integration. Priorities have shifted with the pandemic but integra

Non-Narcotic Order Set: The goal is to design an order set for electronic use that does not contain narcotics, thereby patient s will not be exposed to as many narcotics. Providers are becoming aware that narcotics ar e sometimes not the safest form of pain management. This initiative is still being considere red but has been delayed due to shifting the focus of resources related to COVID-19. Electronic Prescribing of Narcotics: The plan is to make it mandatory for all providers to elect ronically prescribe narcotics. Electronically prescribing medications provides better trac king and drug management, increasing provider awareness of patients' narcotic use. Current tracking of this initiative shows that electronically prescribed medications is above 90% and continued integration will be pursued in order to develop further participation by pr oviders. Provide Staff Training and Education on Drug Abuse: The plan includes education fr om Prairie View Mental Health Center for staff on how to properly identify and care for pa tients with a substance abuse problem. Staff will be able to better identify and care for drug abuse patients and provide better education and referral services upon discharge. Pra irie View, a major mental health provider in the area, conducted staff training onsite for providers in November 2019 on addiction and its effect on the brain. The pandemic has sus pended other opportunities indefinitely. Walk Kansas Co-Sponsorship: In the past, we have t aken an active role and partnered with the Kansas State University Extension Office in McP herson County for this annual spring event designed to encourage teams of 6 or more people to track minutes of physical activity and food choices during an 8-week period. This pote ntially impacts a couple hundred people, encouraging activity and overall good health. Our participation in co-sponsoring this event is dependent on the county extension office see king our support, which did not happen this year. A change in leadership at the county off ice may have impacted the event logistics. We are still considering this event for the spr ing of 2021. Internal Wellness Committee Story Sharing: This program aims to develop person al weight loss and wellness stories of hospital employees that can be shared internally an d externally to encourage others. Leading by example, the impact can be that others in the county will be encouraged to create their own success stories. Before this could be devel oped for the spring of 2020, the pandemic changed much of the operational directives which continue indefinitely. This potentially impacts hundreds of people, encouraging physical activity and overall good health. A virtual run was sponsored in January 2020. Participants logged physical activity over a specified time period. There were over 50 participants. Pair-A-Docs: This is a monthly local radio show where hospital providers and others discuss a variety of health topics. Much of the subject matter in the last year focused on COVID-19 issues. This program served as an invaluable resource for communicating important information to the public. The radio station does not track the number of listeners so that data is not available. Food Insecurity Screenings in the Clinics: The goal is to include two validated screening questions about food insecurity during annual exams in the physician clinics. Eleven percent of people in McPherson County struggle with food insecurity, which increases the risk for obesity and simultaneous malnutrition. Implementing screenings would raise awareness of patients who are struggling with food insecurity, and potentially reduce the risk of obesity by directing them to resources or food assistance programs. Before this could be fully developed and initiated, the pandemic caused a significant change in the number of patients seen in the clinics and the priorities for care, which continues. This initiative is temporarily on hold until we can return to a more normal patient pattern in the clinics. As is evident, the COVID-19 pandemic has significantly limited the hospital's resources and abilities to address the identified health concerns over the last year. Initiatives will continue to be addressed as able.
