THE PURPOSE OF THE PAPER IS TO EDUCATE AND INFORM THE STATEWIDE JEWISH COMMUNITY REGARDING ISSUES RELATED TO THE JEWISH COMMUNITY INCLUDING ITS VALUES, CULTURE AND HISTORY.
