IN THIS FISCAL YEAR IMPERIAL WAY HAS ASSISTED OVER 46% OF THE 86 INDIVIDUALS WITH DEVELOPMENT DISABILITY WE SUPPORTED TO HAVE A JOB IN THE NAPA COMMUNITY WORKING, OVER 2,532 HOURS MAKING MINIMUM WAGE. HOUSEKEEPING, LITTER ABATEMENT, AND YARD MAINTENANCE ARE JUST A FEW EXAMPLES OF JOBS PEOPLE WITH DEVELOPMENTAL DISABILITIES SUPPORTED BY THE IMPERIAL WAY PROGRAM WERE EMPLOYED AT IN FISCAL YEAR 2019-20. PEOPLE HAVE A CHOICE OF THE CLASSES THEY ATTEND, PAID OR VOLUNTEER WORK AND ARE SUPPORTED IN AN EVER-EVOLVING PERSON CENTERED STYLE. WORK OPPORTUNITIES AND CHOICES OF THINGS TO DO IN THE LOCAL COMMUNITY WERE INCREASING UNTIL COVID-19 AND THE PEOPLE WE SUPPORT HAD TO SHELTER-IN-PLACE. (UNFORTUNATELY PEOPLE WITH DEVELOPMENTAL DISABILITIES ARE FOUR TIMES MORE LIKELY TO CONTRACT COVID-19.
