BOARD OF DIRECTORS - THE BOARD OF DIRECTORS (BOARD) IS THE GOVERNING BODY OF THE FOUNDATION. THE BOARD'S MEMBERSHIP IS CONTROLLED BY THE PUBLICLY SUPPORTED ORGANIZATIONS THROUGH THE NOMINATIONS PROCESS. THE BOARD TYPICALLY CONVENES AT LEAST TWICE ANNUALLY IN PERSON AND ALSO CONDUCTS FREQUENT TELEPHONIC MEETINGS IN ORDER TO CONDUCT THE BUSINESS OF THE FOUNDATION. HOWEVER, BECAUSE OF THE COVID-19 PANDEMIC, ONLY ONE IN-PERSON MEETING WAS HELD IN NOVEMBER 2019 AND ALL OTHER MEETINGS WERE CONDUCTED VIA ZOOM OR TELEPHONIC. THE BOARD HAS SEVERAL STANDING AND OTHER COMMITTEES THAT ASSIST IN THE WORK AND GOVERNANCE OF THE FOUNDATION. IT ALSO SETS THE STRATEGIC DIRECTION OF THE FOUNDATION. MUCH OF THE WORK OF THE BOARD IS ACCOMPLISHED IN ITS TELEPHONIC MEETINGS AND AT ITS FACE-TO-FACE MEETINGS. AT THE AMERICAN HEART ASSOCIATION ANNUAL SCIENTIFIC SESSIONS, HELD IN NOVEMBER, THE BOARD GATHERS FOR THE PURPOSE OF CONDUCTING BUSINESS OF THE FOUNDATION, INCLUDING MEETING WITH THE SCIENTIFIC COMMITTEE, WHICH ADMINISTERS THE SCIENTIFIC PROGRAMS OF THE FOUNDATION, AS WELL AS PAST AND CURRENT FELLOWS AND SCHOLARS AND OTHER SARNOFF AFFILIATED INDIVIDUALS. ADDITIONALLY, THE BOARD USUALLY MEETS ANNUALLY AT THE FOUNDATION'S ANNUAL SCIENTIFIC MEETING, HELD IN LATE APRIL OR EARLY MAY, FOR THE SAME PURPOSES OUTLINED BEFOREHAND, AS WELL AS TO PARTICIPATE IN THE SCIENTIFIC ACTIVITIES OF THE MEETING. DURING 2020, THAT MEETING WAS CONDUCTED VIA ZOOM. DURING THE TELEPHONIC AND AT THE AHA SCIENTIFIC SESSIONS AND THE FOUNDATION'S ANNUAL SCIENTIFIC MEETINGS, THE BOARD HEARS REPORTS FROM ITS COMMITTEE CHAIRS AND ACTS ON THEIR RECOMMENDATIONS.
