THE LIGHT HOUSE ADAPTED OPERATIONS ON MARCH 25TH, 2020 AND MOVED CLIENT CHOICE PANTRY AND COMMUNITY SERVICES OUTSIDE OF THE BUILDING DUE TO THE EMERGENCY COVID-19 PANDEMIC. MEALS AND FOOD ITEMS ARE NOW DELIVERED THROUGH A CONTACTLESS DRIVE-THROUGH PANTRY ON TUESDAYS AND THURSDAYS AND A MOBILE PANTRY ON SATURDAYS.
