

ENTREPRENEUR PROGRAM - CIT concentrates on the early commercialization and seed funding stages of innovation, helping tech entrepreneurs launch and grow their companies and create high paying jobs. CIT Growth Acceleration Program (GAP) Funds place equity investments in Virginia-based technology, life science, and clean tech companies. Since the program's inception, \$31.4M in GAP investments have attracted in \$1.1B in private capital. The newly formed Virginia Founders Fund (VFF) serves underserved populations, and created 25 new startups since FY2018. CIT's Federal Funding Assistance Program (FFAP) identifies and accelerates opportunities for Virginia's small technology businesses to obtain SBIR, STTR and ATP awards and other government contracts. Program service revenue consists primarily of proceeds on liquidated GAP investments.

COMMONWEALTH RESEARCH COMMERCIALIZATION FUND (CRCF) - Through its granting program, the CRCF accelerates innovation and economic growth in Virginia by addressing state, national, and international problems. Having awarded \$30M in Commonwealth funding and \$85M in match funding, awardees have received ~\$593M in follow-on funding since FY2015.

CIT was awarded a contract with the Department of Homeland Security, Science and Technology (S&T) Directorate, First Responders Group (FRG). CIT provides highly specialized technical and program support services for the design, development, prototyping and evaluation of emergency response and management technologies and tools for First Responders; understanding the commercial landscape in the evolving Smart City and Internet of Things (IoT) environment; advancing the applied use of Smart city and Internet of Things (IoT) sensors using open standards; and the applied situational awareness, decision support, and commercialization support services to the S&T First Responders Group (FRG) and the S&T Apex Programs. This contract advances the interoperable integration of existing, new and emerging technologies to meet the public safety mission of the First Responder Community.
