This consortium is the only designated entity able to administer the combined public funding of the community arts and cultural organizations.

It provides a common marketing platform that enables the promotion of hundreds, even thousands, of arts and culture events presented by the full spectrum of non-profit arts and culture organizations and artists in our region. The goal of the event is to engage the public in these arts and culture events during ArtoberVA, and throughout the year which leads to greater economic, educational and social impacts in our region.
