The Parent's as Teacher's Program is an in home family education program that works with families who are prenatal through kindergarten entry. Certified parent educators conduct twice monthly home visits that center on the child's development as well as working to strengthen the family.

In addition to home visits, the program offers monthly group connection meetings where families come together to support and encourage each other.

Starting Point Family Resource (SPFRC) operates a fully stocked food, household and hygiene pantry. The SPFRC is responsible for the operation of a resource center which targets programs and services to families with children 0-18 years of age or through high school graduation age.

SPFRC partners with parents and community agencies to work collaboratively to maximize and capitalize on available services within the community.

The Drug Prevention program at the Brooke Hancock Family Resource Network works towards reducing substance abuse in Brooke and Hancock counties through prevention focused on youth and families.

We provide educational resources and evidence based prevention education to local schools. We also maintain a library of prevention materials for distribution throughout the community to promote an alcohol and drug free life style. These initiatives are possible by working with the federal Drug Free Communities and the statewide Substance Abuse Prevention programs. An estimated 40,000 residents have heard or seen our messages throughout local media campaigns including television and radio spots, billboards and newspaper inserts. We support youth initiatives by hosting local RAZE Crew and SADD.

Approximately, 30,000 residents have benefited. The concerned citizens work on homeless issues. We help plan and organize a resource day where community agencies display and discuss information for all community members. We secured funding for Kelsey's Christmas and Christian Fellowship Food Ministry. The first provides gifts and entertainment to children suffering through cancer treatments at Christmas. The second is a Sunday meal with a Christian message and weekend food bags for the youth.
