The board sets budgets, evaluates grant requests, and assists with fundraising, alumni, and other charitable activities related to MHS. Additionally, the organization requires grant applications (see Schedule I) be signed/approved by MHS's Principal and applicable school department chairperson, as well as be approved by a majority of the organization's board of directors. Grant recipients are required to submit a Grant Follow-Up Report (see attachment to Schedule I) detailing the utilization and outcome that resulted from the matter supported by the grant. The principal of MHS regularly attends the organization's board meetings and provides a report as to pertinent school-related matters. Thus, the supported organization has an adequate relationship with the supporting organization and, because of this relationship satisfies the significant voice test. Also, the supporting organization engages in activities for or on behalf of the governmental supported organization (MHS) that perform the functions of, or carry out the purposes of, that governmental organization and that, but for the involvement of the supporting organization, would normally be engaged in by the governmental supported organization itself.
