THEY HAVE NO ELECTRICITY, NO RUNNING WATER, NO EDUCATION, AND THEY LIVE IN VERY REMOTE AREAS. THE LONG DISTANCES THEY WOULD NEED TO TRAVEL BY FOOT PREVENT THEM FROM RECEIVING DENTAL AND VISION SERVICES. THIS YEAR THEY SERVED APPROXIMATELY 1450 PATIENTS. SERVED THANKSGIVING BREAKFAST TO VETERANS AT THE RESTORATION QUARTERS IN COOPERATION WITH ASHEVILLE BUNCOMBE COUNTY CHRISTIAN MINISTRIES. CONTINUED OUR RELATIONSHIPS WITH THE INTERACT CLUB AT ASHEVILLE HIGH AND THE COMMUNITY ROTARACT CLUB, WHICH CONTINUES EFFORTS TO BUILD UPON THE FOUNDATIONS ESTABLISHED - THEY ARE OUR FUTURE. SPONSOR OF FOLKMOOT, AN INTERNATIONAL ORGANIZATION WHICH PROVIDES A CULTURAL EXPERIENCE IN WESTERN NORTH CAROLINA FOR THE GENERAL PUBLIC. STRENGTHENED OUR PARTNERSHIP WITH DAVID LAMOTTE'S PEG PARTNERS ORGANIZATION, TO BUILD A PRE-SCHOOL IN GUATEMALA IN A REMOTE MOUNTAIN VILLAGE. CONTINUED TO RAISE FUNDS AND PROVIDE VOLUNTEERS FOR ASHEVILLE BUNCOMBE CHRISTIAN COMMUNITY MISSIONS'S TRANSFORMATION VILLAGE, A SHELTER AND TRAINING CENTER FOR HOMELESS WOMEN AND CHILDREN.</p>
