The organization builds, sells and repairs homes for families in need. Construction and the sale of 10 homes were completed during the fiscal year ending June 30, 2020. Persons served totaled 12 adults and 15 children. Of these homes, 9 were headed by females and 1 home was purchased by a Caucasian married couple. 2 homes (20%) of the families were below 50% of the area median income, 5 homes (50%) of the families were below 50% of the area median income and 3 homes (30%) were below 70% of the area median income. One family had a disabled family member and seven families had African-American members. Eight homes were headed by a single parent. The Organization also preserved existing homes through the repair of 53 homes. This includes the homes of 3 veterans, 6 disabled, 45 elderly and 43 families headed by females. Fifteen households were below 25% of the area median income, 29 households were between 25%-50% of the area median income and 9 households were between 50%-70% of the area median income.

For the fiscal year ended June 30, 2020, 1,629 volunteers donated 41,375 hours of time.

The compensation of the Executive Director is included in the compensation plan and the annual review. Wage and salary increases are presented in total and by department to the Board of Directors for approval along with the annual budget. Periodically, the compensation plan is tested against information from a regional service bureau to ensure that wages and salaries are reasonable for the Western North Carolina region. A report of this test is reviewed by the Human Resources Subcommittee of the Board of Directors and was last made during the fiscal year ending June 30, 2019. The Human Resources Subcommittee will be evaluating the compensation plan periodically to ensure that wages and salaries are reasonable for the Western North Carolina region.**
