During the 2019-2020 school year, MeckEds Career Pathways initiative served over 2,000 students in six Charlotte-Mecklenburg High Schools by providing work-based learning opportunities and intensive support, career training, placement, and coaching for over 160 of the regions highest need students. MeckEds Out of School Time initiative, Charlotte NEXT, launched a program Locator to help parents and caregivers find enrichment programs for children. Since it was launched in early 2017, Locator has received over 13,000 online visitors and today is profiling over 500 different enrichment programs! Additionally, MeckEd provides professional development for After-School enrichment providers who, together, are positively impacting over 10,000 students. A pilot program in three high-need CMS middle schools is supporting five different program providers who are offering over 6,000 additional hours of enrichment to students. A partnership with the Mecklenburg County Youth Coalition and the Mayors Mentoring Alliance has resulted in including mentors on Locator. MeckEd also holds six Community Conversations annually to assist in spotlighting critical issues related to young people and their preparation for success. During the past year, MeckEd informed and engaged over 150 civic leaders and program providers on topics that included Effective Career and Technical Education, The Impact of Desegregation and Re-segregation on CMS Children and Families, and The Power and Promise of Out of School Time Enrichment Programs.

On March 16th and with the support of our largest funding partner Charlotte Works, we purchased six Zoom Pro accounts. Our Career Pathways Advisors began reaching out to the students on their caseloads daily. By April the team had pivoted (as did the rest of the world) to virtual programming. The upside of this was that we were able to open our programs to additional students and schools. From April-June 2020 we served approximately 250 students (duplicated), we offered a variety of programming opportunities such as virtual post-secondary exposure opportunities, job shadows, mentoring, and workshops. Program participants tuned in to virtually tour Howard University, Harvard, NC State, Queens University, and University of North Carolina at Greensboro. We also hosted over 20 virtual opportunities with the following companies: B. Well: Live Consciously, Duke Energy, Innovate Tech Charlotte, Sharon Towers, Fuzion Force Dance Studio, STEM Explore, and Twins Center Obstetrics and Gynecology among others. Topics covered during virtual experiences include: Entrepreneurship, Robotics & Technology, Healthcare, Social Work, Mental Health, Customer Service, Drone Operators, Line work, Manufacturing, and much more. Here is a sampling of programs and participation between September and December 2020. We were able to provide virtual experiences with: CMPD, Bank of America, Ally Bank, B&W Sweets, Microsoft, Clark Hall Doors, Road to Hire, and a session on knowing your rights with Judge Bahiyya Walker. Over 116 (duplicated) students attended these virtual events. InternshipsAs businesses began to slowly and responsibly reopen, we were able to place participants in several in-person internships beginning in September 2020. THE LEARNING LAB beyond having a Chromebook and a WIFI Hotspot, the youth we serve need a safe and supportive place to learn. In August 2020, MeckEd converted its 3,000 sq.ft offices into a Learning Lab. Desks are spaced eight feet apart and wrapped with acrylic shields. Temperature is taken at the door. Laptops and reliable internet access is provided. Hand sanitizer is available and hospital grade cleaning takes place daily. The Lab opens at 7:30am and hosts approximately 24 students every week from Garinger, Harding, Vance, and West Charlotte.</p>
