Now, 30% (was 10%) of voting memb ers are required to be present for a quorum to exist.The Board of Directors changed from 12 to 22 elected/appointed directors. Additionally, ex-officio, non-voting directors increa sed from 10 to 17 ex-officio directors. Some are appointed based on membership class with six members from the Sustaining member class and three members from the municipalities. Tw elve members are elected from the private member class which also has four sub-level class es including Platinum, Gold, Silver, and Bronze. These levels are based on the amount cont ributed by each memmber. These members are nominated by the private members of each level. The immediate past board chairman also serves as a director. Directors are elected to ser ve three year terms instead of two year terms and can serve no more than two consecutive t erms. A majority of the board of directors present at meetings shall constitute a quorum. T he Board will name a nominating committee to administer the nomination procedures. It rema ins that the Board of Directors shall receive no compensation but may be reimbursed for re asonable expenses incurred as approved by the Board.Officers shall consist of the Chairman of the Board, Vice-Chairman, President, Secretary, Treasurer, and other officers as deeme d necessary. Officers shall be elected by the Board at its annual meeeting and shall serve one year terms. Officers may continuing serving until such time a new officer is elected.
