The panelists are provided with a panel book which includes information on the panel review process, copies of the grant guidelines, copies of the grant applications, a scoring sheet, and a conflict of interest statement. Each grant is reviewed and discussed, and then each panelist is asked to score the application based on the following: "Artistic quality of proposed project or program "Community impact of project or program "Stability and fiscal responsibility of the organization "Ability to plan and implement a project After all of the grants have been scored, the committee reviews the scoring breakdown and determines levels of funding. The committee must fund the appropriate level of multicultural programs to meet the county's multicultural programming allotment. The panel's recommendations are then presented to the Arts Council of Wilmington and New Hanover County's board of directors, and the board votes on the recommendations. Following the board's endorsement, the Arts Council communicates with all of the grant applicants about the board's decision. The aforementioned process relates to the Grassroots grants. The same process is used for the Regional Artist Project grants, except the Arts Council also secures professional evaluations of the work samples from community members with expertise in specific disciplines. The panelists consider the professional evaluations when ranking applications.
