At June 30, 2020, the Foundation was servicing a loan portfolio valued at \$1,076,801,482 and administering North Carolina's National College Savings Program with a portfolio valued at \$2,694,191,618. During the tax year ended June 30, 2020, students used the CFNC.org website to submit 388,828 applications to NC colleges, 348,138 students used the Residency Determination Service, and the Foundation disbursed \$257,834,296 in state grants.
