EXHIBIT A

AMENDED AND RESTATED ARTICLES OF INCORPORATION OF THE MEDICAL FOUNDATION OF NORTH CAROLINA, INCORPORATED

1. The name of the corporation is UNC Health Foundation Inc. (the "Corporation").
2. The Corporation is a charitable corporation as defined in Section 55A-1-40(4) of the North Carolina General Statutes.
3. The name of the current registered agent of the Corporation is C T Corporation System, and the street address, mailing address and county of the current registered office is 160 Mine Lake Court, Suite 200, Raleigh, North Carolina 27615 (Wake County).
4. The street address, mailing address and county of the principal office of the Corporation is 123 W. Franklin Street, Suite 510, Chapel Hill, North Carolina 27516 (Orange County).
5. The period of duration of the Corporation shall be perpetual.
6. The Corporation will not have members.
7. The purpose for which the Corporation is organized shall be to promote the welfare and development of the School of Medicine at the University of North Carolina - Chapel Hill ("UNC School of Medicine") and the UNC Health Care System ("UNC Health Care") in their educational, scientific and public service purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended ("the Code"), and to receive gifts which qualify under Section 170 of the Code or the corresponding provisions of any future federal revenue laws; to seek gifts for the benefit of the UNC School of Medicine and UNC Health Care through current funds, endowment giving and other fund raising programs; and to oversee the investment and disbursement of these assets within a policy that encourages the enhancement of the resources of the Corporation, the UNC School of Medicine and UNC Health Care. The purposes, mission and strategic plan of the Corporation shall be established or modified only by the Board of Directors.
8. In order to prosecute properly and carry out the objects and purposes herein set forth, the Corporation shall have the full power to receive donations, bequests, devises and gifts of money and property; to purchase, lease, invest, reinvest, and otherwise dispose of all kinds of property, real, personal and mixed; to administer and make expenditures to or for the benefit of the UNC School of Medicine and UNC Health Care and all departments, branches, institutions, laboratories and research organizations which are part of the UNC School of Medicine and UNC Health Care; and, generally, do any and all acts and things which may be deemed necessary or expedient for the development, expansion and extension of education and research for the advancement of medical and related fields of knowledge at the UNC School of Medicine and UNC Health Care.
9. The Corporation is a nonprofit, charitable, and educational corporation and has no capital stock.

10. The management of the Corporation and its properties shall be vested in a Board of Directors which shall have the power and authority, from time to time, to sell, expend or otherwise dispose of any and all property of the Corporation, real, personal, or mixed, in furtherance of any of the objects and purposes for which the Corporation is formed. The number of directors of the Corporation shall be provided for and determined by the bylaws of the Corporation. The directors may delegate any part or all of their duties to an Executive Committee or any other committees as may be provided for from time to time by the bylaws of the Corporation.
11. In the event of dissolution or other termination of the Corporation, the Board of Directors, after paying or making provision for the payment of all of the liabilities of the Corporation, shall distribute all of the net assets of the Corporation to the UNC School of Medicine and UNC Health Care, Chapel Hill, North Carolina.
12. Except to the extent that the North Carolina General Statutes prohibit such limitation or elimination of liability of directors for breaches of duty, no director of the Corporation shall have any personal liability arising out of any action whether by or in the right of the Corporation or otherwise for monetary damages for breach of any duty as a director. No amendment to or repeal of this Article 12 shall apply to or have any effect on the liability or alleged liability of any director of the Corporation for or with respect to any acts or omissions of such director occurring prior to such amendment or repeal. The provisions of this Article 12 shall not be deemed to limit or preclude indemnification of a director by the Corporation for any liability that has not been eliminated by the provisions of this Article.
13. No director of the Corporation shall receive any compensation whatever for, or in connection with, his or her services as a director of the Corporation.
14. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Amended and Restated Articles of Incorporation ("the Articles"). No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of (or in opposition to) any candidate for public office. Notwithstanding any provision of these Articles, the Corporation shall not carry on any activities not permitted by: (a) a corporation exempt from Federal income tax under Section 501(c)(3) of the Code, or (b) a nonprofit corporation formed under Chapter 55A of the North Carolina General Statutes.
15. The foregoing supersedes all prior Articles of Incorporation and Amendments to Articles of Incorporation, including those in the corporate name of The Medical Foundation of North Carolina, Incorporated.
