THE HOMES ARE BUILT BY CHFH'S CONSTRUCTION CREW AND HUNDREDS OF VOLUNTEERS. THE MORTGAGES VARY IN LENGTH BETWEEN 20 AND 30 YEARS AND CARRY ZERO PERCENT INTEREST. SINCE 1989, CHFH HAS BUILT 92 HOMES FOR WORKING FAMILIES IN THE CITIES OF CHARLESTON AND NORTH CHARLESTON, SOUTH CAROLINA.
