THE ROTARY CLUB ACCEPTED APPLICATIONS FROM LOCAL 501(C)3 CHARITABLE ORGANIZATIONS FOR SELECTION AS A MAJOR PROJECT FOR THE FUNDRAISING EFFORTS. EACH APPLYING ORGANIZATION WAS CAREFULLY VETTED BY THE PROJECT COMMITTEE TO ASSESS LEGITIMACY, NEED, USE OF FUNDS, AND APPROPRIATENESS TO THE ORGANIZATION'S ABILITY TO COMPLETE THE PROJECT. DOCUMENTATION OF THAT PROCESS WAS RETAINED BY THE COMMITTEE. GRANTS TO COMMUNITY FOUNDATION OF THE LOWCOUNTRY ARE DEPOSITED INTO ENDOWMENT AND QUASI-ENDOWMENT FUNDS TO BE INVESTED AND MANAGED.
