ON SEPTEMBER 8, 2020, THE UNIVERSITY CONTINUED REMOTE INSTRUCTION FOR THE FALL SEMESTER. IN APRIL 2020, THE U.S. DEPARTMENT OF EDUCATION (DOE), UNDER THE CARES ACT, BEGAN DISTRIBUTING FUNDING TO ELIGIBLE INSTITUTIONS OF HIGHER EDUCATION. THESE FUNDS WERE DISTRIBUTED AND INTENDED TO SUPPORT STUDENTS AFFECTED BY THE EARLY CLOSURE OF CAMPUS AND NEEDS RELATED TO REMOTE INSTRUCTION, AS WELL AS, SUPPORTING THE OPERATIONS OF THE INSTITUTION. ADDITIONALLY, AS PART OF THE CARES ACT, THE UNIVERSITY OBTAINED A LOAN UNDER THE PAYROLL PROTECTION PROGRAM IN ORDER TO RETAIN EMPLOYEES AND MAINTAIN PAYROLL DURING THE COVID-19 PANDEMIC.
