International students comprise approximately 25 percent of the student body. The faculty averages 15 years of teaching experience, with an average of 8 years at RGNS. Of the 54 classroom teachers and 1 residential faculty, 60 percent hold graduate degrees or higher. Advanced Placement (AP) courses are offered in all academic departments with over 146 students enrolled in an AP course and the majority of the AP candidates received a score of 3 or higher, making them eligible to receive college credit for their work.
