THE FOUNDATION ALSO PROVIDED FUNDING FOR RENOVATIONS ON THE THIRD FLOOR OF SYCAMORE SHOALS HOSPITAL, THE COMPLETION OF A HEALING GARDEN AT JOHNSON CITY MEDICAL CENTER, DIAGNOSTIC EQUIPMENT FOR WOMEN IN SMYTH COUNTY, FURNISHINGS AND DECOR FOR THE GREENEVILLE COMMUNITY HOSPITAL CAFETERIA, AND A NUMBER OF PIECES OF PATIENT TRANSPORT EQUIPMENT IN DICKENSON COUNTY. DURING THE SAME TIME PERIOD OVER \$196,000 WAS PROVIDED TO SUPPORT EDUCATIONAL PROGRAMMING FOR PATIENTS AT NISWONGER CHILDREN'S HOSPITAL, \$116,899 WAS PROVIDED TO SUPPORT THE HEALTH SYSTEM'S POPULATION HEALTH OBJECTIVES, AND THE FOUNDATION SUPPORTED THE HEALTH SYSTEM'S PARISH NURSING PROGRAM WITH \$22,602.
