The school may apply for PPP loan proceeds to be forgiven with the lending institution, provided the proceeds are used within a specified timeframe to cover certain payroll and other expenses as outlined in the CARES Act and the PPPFA. Initial repayments of the loan amounts are deferred until the date the SBA remits the loan forgiveness funds to the lending institution, or until 10 months after the end of the forgiveness covered period if the School does not apply for forgiveness. The loan matures April 2022; the PPPFA allows the maturity date to be extended from a 2-year period from loan origination to a 5-year period from loan origination subject to approval by the lending institution. The School intends to apply for complete forgiveness of the PPP loan in 2021.
