BackPack Buddies - Provides weekend meals for food insecure students throughout Cartersville and Bartow County. Currently, 1,400 students are receiving backpacks with food to carry them through the weekend.

**4b** (Code: ) (Expenses \$ 62,707 including grants of \$ 62,707 ) (Revenue \$ 50,083 )  
GateKey Scholarship Program - Provides 2-year scholarships to eligible, low-income students giving them the opportunity to work toward an attainable goal of a college education. GateKey provides funds for tuition, fees, and books with an option to attend one of two local colleges. They may petition the Foundation Board to use funds as a scholarship to attend another accredited college. Students may be nominated in grades 9-12. If selected, students are mentored and are required to maintain at least a "C" in each class, complete all work, and have no attendance or discipline issues. To date, more than 180 students have been impacted by GateKey.

Least of These Student Support - Provides assistance to students identified as homeless or low-income. Assists with needs that cannot be met using tax money or federal grant funds. Program levels the playing field between socio-economic groups so students are able to participate in extra-curricular school activities and have all items necessary to be academically successful.
