If unauthorized changes have occurred or the easement property requires maintenance, the letter will urge the easement owner to contact PSABC and schedule consultation or action to address these concerns.

Preservation easements typically assign the development rights of property to the Preservation Society of Asheville and Buncombe County, thereby protecting it from development from current or future landowners. Although the removal of development rights of land has a measurable devaluation to the landowner, they have no attainable value to the Preservation Society of Asheville and Buncombe County. There is no market or market value for easements in the hands of the Preservation Society of Asheville and Buncombe County and the easements in fact impose a financial burden on the organization. Easement donors, while helping the Preservation Society of Asheville and Buncombe County satisfy preservation objectives, actually impose financial responsibilities on the organization through their ongoing monitoring requirements. Therefore, easements acquired by the Preservation Society of Asheville and Buncombe County are accounted for as "zero balance" assets and are therefore, not reflected in the organization's financial statements. The cash components received with regard to the easements are reported as income on the organization's financials.
