THIS PROCESS IS TYPICALLY UNDERTAKEN ANNUALLY; HOWEVER, THE ORGANIZATION DID NOT CONDUCT THIS REVIEW DURING FYE 6/30/2020 as management froze all employee salaries for a year due to the COVID-19 pandemic.
