Grantmaker's Description of How Grants are Used	The Ohio Community Pooled Annuity Trust (OCPAT) is a medicaid pooled trust for individuals with disabilities within the meaning of 42 USC Section 1396P (D)(4)(C). With the assistance of its brother/sister organization, The Disability Foundation, annuity amounts are calculated based on the annuity rate for the month cash or securities are transferred to OCPAT and the age of the individual with disabilities. This is a fixed rate and guaranteed for the individual's lifetime. Each month the annuity amount is allocated to a Spending Account, which is an in-house accounting tool used to monitor the funds an individual has access to for distribution. Each month, the Executive Director completes a monthly valuation of each individual's spending account to account for the increases and decreases in the spending account. This valuation is reviewed by the VP of Finance of The Dayton Foundation. After an annuity is funded for an individual with disabilities, his/her personal representative is given a request for distribution form each quarter which can be submitted to the Distribution committee to ensure that the requested distribution would meet the state of Ohio standards for supplemental needs and would be used solely for the benefit of the individual with disabilities. Once approved, a check is issued to the personal representative to meet the supplemental need. The personal representative is required to provide documentation of how the funds are spent.
