 Friends of Nazareth (FON) had about 150 volunteers schedule to volunteer for various projects during the fiscal year. The main thrust during each year are four (4) camps conducted during the summer during June to August. Due to the FON fiscal year, the camp expenses, which include a grant for the camp to help keep costs reasonable, these costs are spread over two fiscal year. The expenses included \$21,638 to the school for three mission projects. In the fall of 2019, FON teamed with another non-profit to conduct a Student Leadership 101 conference for about 150 students and a Spiritual enhancement Journey were church leaders and pastors worked with churches in the area. A team to help support a Mother's Day emphasis at the school was scheduled to arrive in March 2020 and a renovation team was scheduled to arrive in April 2020. Both of these trips were canceled at the last minute due to the Coronavirus Pandemic, which subjected both of these teams to potentially large cancellation costs. All of the 2020 summer camp teams were cancelled.

4b (Code:) (Expenses \$ 204,940 including grants of \$ 204,940) (Revenue \$)
 The Nazareth Baptist School facility is old. The school had water damage due to heavy rains in CY2018 and some of the funds were used to complete projects associated with the water damage. Due to increased earthquake activity, the Israeli government conducted a survey of all schools. This review indicated the high school wing was at risk of a collapse if the school experienced a major earthquake. Some of the funds were used to complete work associated with the earthquake remediation. Funds were used to complete renovation of the Chapel and Prayer Room.

 Friends of Nazareth has teamed with the Southern Baptist International Mission Board and the Shandon Baptist Church, Columbia, SC to support a missionary couple and their Childrens and Family Ministry (CAFM). Their ministry includes volunteering and performing and performing ministry at the Nazareth Baptist School
