AN EXAMPLE OF A DISTRICT-WIDE STRATEGIC PROGRAM IS THE STEM AND STEAM CURRICULUM WHICH WAS FUNDED DURING THE CURRENT YEAR. THE PANHANDLE ALLIANCE FOR EDUCATION PROVIDED 184,000 FOR NEW CURRICULUM IN THE AREAS OF SCIENCE, TECHNOLOGY, ENGINEERING AND MATH OR 'STEM' (WHEN ART IS ADDED TO THAT PROGRAM IT IS REFERRED TO AS "STEAM"). STEM IS AN APPROACH TO THE WORLD, A CRITICAL WAY TO UNDERSTAND AND EXPLORE AND ENGAGE WITH THE WORLD AND THEN HAVE THE CAPACITY TO CHANGE THAT WORLD. ELEMENTARY SCIENCE CURRICULUM WAS LAST PURCHASED IN OUR SCHOOL DISTRICT IN 2006. SECONDARY CURRICULUM DATES BACK TO 2001. THIS FUNDING PROVIDES SCIENCE KITS FOR CERTIFIED STAFF AND TWO DISTRICT INSTRUCTIONAL COACHES TO SUPPORT PROFESSIONAL DEVELOPMENT STEM IMPLEMENTATION AND ON-GOING TEACHER SUPPORT. THE FOCUS ON STEM IS IN PART DUE TO THE PROJECTED PERCENTAGE INCREASE IN STEM EMPLOYMENT OF UP TO 60% AND PAPE'S DESIRE TO ENCOURAGE STUDENTS TO ENGAGE EARLY AND DEVELOP SUCCESS IN THIS AREA.

PANHANDLE ALLIANCE FOR EDUCATION ALSO PROVIDED FUNDING IN THE AMOUNT OF 137,000 FOR ENDOWMENTS HELD BY THE IDAHO COMMUNITY FOUNDATION AND THE INNOVIA FOUNDATION FOR PERPETUAL FUNDING OF THE OPERATING GRANTS FOR THE LAKE PEND OREILLE SCHOOL DISTRICT.
