Between February 2007 when the program was launched and June 30, 2020, 126 productions have completed principal photography including 46 features, 18 episodic projects, 57 commercials, 3 short films, and 1 virtual reality project. These productions have collectively spent over \$140.4 million in communities all across Washington State, while receiving \$39.8 million in financial incentives. The return on investment represents real economic development for the State of Washington.
