ADDITIONALLY, THIS YEAR WE ASSISTED ASSOCIATES AFFECTED BY THE TORNADO THAT HIT MIDDLE TENNESSEE IN MARCH BY PROVIDING OVER \$43,000 IN ASSISTANCE THROUGH OUR RENEWING HOME FUND. SAINT THOMAS HEALTH SENIOR LEADERS AND ASSOCIATES PARTICIPATE AS ACTIVE BOARD MEMBERS OF NON-PROFIT ORGANIZATIONS WHOSE MISSIONS ALIGN WITH COMMUNITY HEALTH IMPROVEMENT AND ADDRESS SOCIAL DETERMINANTS OF HEALTH.
