Explanation: Due to the Covid-19 pandemic situation, the financial information required to prepare this form accurately was not available by the original due date. By this date, the Company's offices continue to be temporarily closed due to the restrictions imposed by the Puerto Rico government. Also, the accounting and tax professionals engaged to collect and organize financial data used to prepare the returns have been affected by the pandemic. In addition, multiple tax professionals in charge of preparing the tax returns became ill with COVID-19 around the filing due date, causing the CPA Firm to suddenly close operations, and multiple professionals were weeks on sick leave due to COVID positive test results. Positive test result evidence is available upon request. We respectfully request the waiver of any late filing penalties as this may impose a significant burden given that the revenues have been dramatically affected during this pandemic.
