This is a permanent supportive housing program which began in March of 2013. The Dixon VETS Housing program is a VA Grant and Per Diem funded program. This program achieved all performance measures set by the VA and CAN-B as well as passed the clinical inspection for the third year running. HUD Homeless Assistance Center is operated with Solano County Health and Human Services. This funding is for supportive services only and allows for the provision of Homeless prevention and rapid re-housing services, supplemental food, employment referrals and job training as well as VA fiduciary and Representative Payee services.
