It also assisted participants with computer skill development, applications for college and financial aid, as well as assistance with applications and recertifications for food stamps, unemployment benefits, housing, etc. Over 250 people participated in the program. Over 60% of the students who completed a post-test advanced at least one NRS level.

Emergency Assistance the program provided financial assistance, advocacy and referrals for people facing eviction, loss of utilities, or other crises situations.
