For fiscal year ended June 30, 2020, tax year 2019, Monte Cassino Charitable Trust awarded \$147,500 to the scholarship fund for the 2019-2020 school year, and \$147,500 for capital projects, also for the 2019-2020 school year. The gross contribution of \$295,000 was paid in July 2019.
