IN FISCAL YEAR 2020, \$13,000 IN ACADEMIC SCHOLARSHIPS WERE AWARDED BY THE FOUNDATION. INDIVIDUALS WHO ARE AWARDED SCHOLARSHIPS ARE ELIGIBLE TO CLAIM THEIR SCHOLARSHIP AS THEY ENTER COLLEGE OR TECHNICAL SCHOOL. IN FISCAL YEAR 2020, THE FOUNDATION PAID OUT \$37,886 IN SCHOLARSHIPS.
