The monitoring follows a defined scope and program which FAWIC has developed for each service provider's monitoring. Whenever FAWIC discovers any irregularities, these are resolved as soon as possible and not left for the more formalized audit. After the financial monitoring is completed, the auditor discusses the findings with the service provider's director and financial officer.
