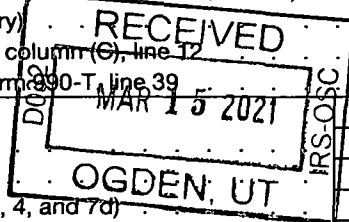

TAY in our program have maintained housing, increased their wages and achieved educational progress. Services and support continued through the Covid-19 crisis, with appropriate safety adjustments.
