Our mission is to provide free, confidential instruction to enable Ravalli County adults to become literate or complete their High School Equivalency (HSE) Diploma so they can succeed as workers, parents, and citizens. We also help our students gain skills to enter the workforce or enter additional education or training. Our students range in age from 16-75 years old with a variety of basic education goals--many students study Mathematics.

117 participants enrolled to learn basic reading, writing, and math skills through one-to-one and small group instruction. Students are 16 or older and not enrolled in public school. They seek to improve their lives and the lives of their families through education. The program includes direct instruction to enable students to better function on the job, in their families, and in society. 47 students completed their high school equivalency diploma and 19 entered college or technical training.
Explanation of grants: 62 students received scholarships for testing fees for the high school equivalency exam, ranging in amount from \$15 to \$75 per person and totally \$3,414. Payments were made directly to the test center so the funds could not be used for any other purpose. Local private donations provided the funds to pay the testing fees for all our students during the year.

Family Literacy activities included the distribution of 571 new books to low-income children 0-5 years old who are enrolled in Head Start or Early Head Start. Books were purchased with a contribution from the Bitterroot Valley Kiwanis Club and children were allowed to choose their own books to take home and read over and over with family members. Volunteers conduct this wonderful project.
