BY FEBRUARY 2020, THE 57 ARTISTYEAR AMERICORPS FELLOWS WERE ON PACE TO PROVIDE THE LARGEST NUMBER OF RESOURCES AND OPPORTUNITIES IN OUR HISTORY TO 12,687 STUDENTS TWICE-WEEKLY, FROM LOW-INCOME HOUSEHOLDS AT 51 TITLE I PARTNER SCHOOLS ACROSS THREE LOCATIONS: NYC, PHILADELPHIA, AND RURAL COLORADO. FELLOWS HAD ALREADY CONTRIBUTED 85 COMMUNITY ARTS EVENTS, 69 FIELD TRIPS FOR STUDENTS, RAISED \$21,678 FOR ARTS IN TITLE I SCHOOLS, CREATED 56 NEW OST ARTS CLUBS, AND TAUGHT OVER 73,000 IN-PERSON HOURS. FOUNDED AS A VIRTUAL ORGANIZATION, ARTISTYEAR WAS ABLE TO ADAPT IN RECORD TIME TO NOT ONLY CONTINUE WITH DIRECT SERVICE FOR ARTISTYEAR STUDENTS, BUT TO ALSO PRODUCE AN ADDITIONAL 108 HIGH-QUALITY, SEQUENTIAL ARTS EDUCATION VIDEO PROGRAMS THAT WERE FEATURED AND VIEWED BY 70,400 UNIQUE VIEWERS ON #CAMPYOUTUBE, THROUGH 804 HOURS. BY JUNE 2020, THE ARTISTYEAR FELLOWS HAD DEDICATED WELL OVER 97,000 HOURS OF SERVICE.
