Service goals and objectives can include: counseling, employment, education, transportation, finances, and permanency. Fostering Acadia utilizes the Casey Life Skills Assessment as one of its main measuring tools for youth outcomes. During the tax year, Fostering Acadia served 42 youth, over an average stay of 365 days. During this time 95% of the enrolled youth increased their independent living skills, as measured by comparison to their ISP, Casey Life Skills Assessments and FAPT goals.
