IWCF members then select the projects by voting in the areas of cultural arts, education, environment, financial stability, health, and rural communities. In addition, five runners up were each awarded a small award. During fiscal year 2020, 70 members participated on the Grants Committee to narrow 59 letters of inquiry to 12 ballot choices in the 6 interest areas. In the fiscal year ending June 30, 2020, the IWCF distributed \$215,187 in pooled grants and \$203,800 in individually designated grants. There were 229 qualifying organizations receiving the individually designated grants in amounts of \$250 and \$500.
