We help expose our survivors to diverse methods of workouts including running, walking, swimming, barre, yoga, weight training, and more so they can find a program that works for them and their post-cancer body. We partner with local gyms to provide complimentary workouts, and also have a scholarship program to help cover the costs associated with gyms, nutrition, or workout equipment.
