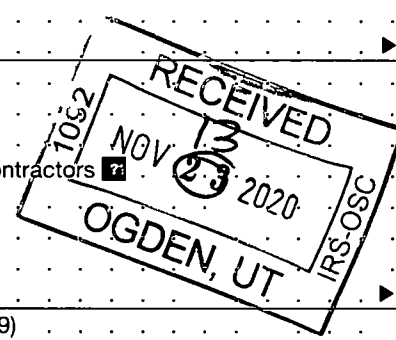

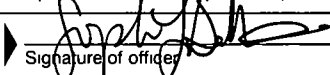

**English Initiative**

One of Asali's major points of focus is English language development. English is critical for Tanzanian students' education, as after Standard 7 (ages 12-14), the entire education system switches from Swahili to English. Access to education beyond Standard 7 is dependent upon a passing score on the National Exam, which contains a difficult English language section. Many students are unable to complete their education because they are unable to pass the exam. Due to these challenges for the students, Asali's flagship program is focused on increasing access to high-quality English education. Our current English initiative is two-fold: providing an English Club during school hours and teacher training after school.

This past year Asali reached a total of 290 children through our English program through our continued work with three primary schools, Lagoni Primary School, Mji Mpya Primary School and Miembeni Primary School. All of these schools are among the five primary schools in Simba's community. After collaborative meetings between school headmasters, Simba's representatives, and Asali board members, English programming will continue for students in three grade levels at each establishment. We look forward to strengthening our relationship with

both schools as we continue to collaborate. Our students are excited and engaged during class and have reported that they greatly enjoy the interactive teaching techniques. In addition to these classes for school aged children, Asali has piloted an Early Childhood Education program that aims to provide early access to English education for younger children in the community. Currently, 20 children are enrolled in this program and attend class at Simba's Footprints

Another important piece of the English Initiative is teacher training for educators at the Langoni School. Training the teachers to use multi-sensory, interactive teaching methods enriches their practices and their own English proficiency. This mentorship-style program encourages educators to be more impactful with the children in their classes and their communities. This ripple effect will allow Asali to reach many more students through different teachers and schools than would be possible as an isolated organization. To date, Asali has hosted 8 of these trainings open to all teachers who choose to attend.

Finally, as part of our education initiative, Asali established a library at Simba's Community Center in FY18, which remains the only Library in the Majengo community

Last year we did a major renovation of our library at Simba's Footprints. Thanks to a grant we received from New Leaf Fund, we were able to completely renovate the space including painting the walls, adding a mural, and building new furniture.

Thanks to these renovations, we were able to implement new uses for the space. Often students are unable to purchase study books on their own and are unable to study effectively at home with a lack of electricity or space. In response to this, Asali purchased copies of all secondary study materials and has open library hours. This space hosts the Early Childhood Education Program, as well as the study hall for secondary students.

Asali's investment in the English Initiative for this fiscal year totaled \$4504.

**Music Program**

In response to an outpouring of requests from Simba's Footprints students and community members, Asali built its music studio. Asali filled the refurbished room with donated guitars, keyboards, a public address (P.A.) system, bass guitar, drums and microphones. This year, Asali added a full drum set to the studio for students to grow their understanding of rhythm.

Our little studio is being managed by a fantastic music teacher who provides either weekly or biweekly lessons for our students. The excitement from our students about learning a new instrument and working together to create music is palpable.

This year, the Asali Music Studio hosted the Kenyan musician, Fadhilee Ituyila, who was recently nominated for Best African Jazz album. Ituyila put on two separate workshops to help expand our students' knowledge of jazz, african music, and living as a musician. After the second workshop, our music teacher took his students to a studio to learn about music production and record their first song.

**Health Program**

This year, Asali substantially expanded on the healthcare initiative piloted in FY18. Thirty four additional medically vulnerable children at Simba's were enrolled in healthcare along with the 30 students from the previous year, bringing the total number of children receiving health insurance to 64. Using information from medical visits, Simba's social worker is able to track other ongoing issues and assist with prevention and further treatment The insurance coverage itself was expanded to include all medical expenses, prescriptions and surgeries at multiple hospitals across Tanzania.

In response to the COVID19 global pandemic, Asali worked in conjunction with Simba's Footprints to provide substantial resources for the community This included a two phase response in April of 2020 and June of 2020. Phase 1 of the COVID19 project consisted of creating 200 Family Care packages to help the families in the community respond to the unexpected economic and physical shutdown of Tanzania due to quarantine and lockdown measures, making 700 reusable masks sewn by members of the community, and building and delivering five touch-free hand washing stations to common areas in the community. In addition, health advisories and information from WHO were translated into Swahili and posted around the area in multiple frequented sites. During Phase 2 of the COVID19 project, Simba's and Asali provided all students attending Simba's activities with masks, hosted teacher trainings at all four primary schools on how to reopen schools as safely as possible based on the resources created by Heal International, and placed large hand washing stations and soap at each school.

Finally, at the beginning of this year, Asali hosted a registered nurse from Mass General Hospital in Boston, Massachusetts who held trainings for both Simba's staff and primary school

**Operations**

This year's operating budget primarily went toward the planning and execution of fundraising initiatives. As Asali is currently running on public support donations, fundraising events include an outdoor garden party to explain our work and our mission, evenings at a restaurant, and online campaigns. Other operations costs include bank wires, shipping fees, website fees, and federal/state tax filing fees. Total cost in FY19 was \$1,332.
