



The organization started constructing a school building on a 37-acre land which few individuals from the U.S leased to the organization rent-free. The construction started in March 2017 and the first phase of the construction was completed by October 2018. The first phase will include the building of enough classrooms for Kindergarten to the second 2nd grades. Phase two construction will immediately follow that and will be completed by October 2021. Phase two will include the building of enough classrooms for all primary grades (1st through 6th). Phase three construction will be completed by 2024 for middle school (7th through 9th). Phase four construction will be completed by 2027 for high school (10th through 12th).
