I.B.E.W. Local 415 By-Laws require class A members participate in the self-perpetuating Local death Benefit fund which provides immediate funds to help the beneficiaries of the member who passed away.

I.B.E.W. Local 415 By-Laws allow for the Stocker Scholarship Award Program. The member or one of his/her immediate family can apply for a scholarship to further their education after high school/ged. There is a committee that reviews the applications and makes award recommendations that are reviewed by I.B.E.W. Local 415's Executive Board.
