During the year ended June 30, 2020, the Colorado Cattlemen's Agricultural Land Trust (CCALT) worked with ranching families and partner organizations to permanently conserve approximately 6,580 acres of ranchland and open space on ten properties. We also transferred and updated an existing easement on approximately 17,700 acres of ranchland from a partner land trust to CCALT with the support of the landowners and several other organizations. On October 1, 2019, CCALT completed a merger with the Yampa Valley Land Trust, Inc. (YVLT) to increase conservation efficiencies in Northwest Colorado. When combined, CCALT and the former YVLT easements now total approximately 656,000 acres conserved. See Schedule O for additional information regarding the merger. CCALT continues to work with our partners to advance and support land conservation in Colorado and nationwide. These efforts will help to ensure that conservation easements remain a viable tool for Coloradans and that their benefits continue to impact not only the agricultural community, but Colorado's robust tourism, recreation and outdoor industries as well. We are proud of our accomplishments and are thankful for the generous support of our landowners, donors and partners.

Part II, Line 3:	CCALT modified four conservation easements in the 2019-2020 fiscal year. Modifications included: (1) an amendment to reduce the size and alter the configuration of a parcel which was permitted to be subdivided; (2) an amendment to eliminate building rights on a conserved property; (3) and two modifications to add acreage to conserved land. All of the modifications followed CCALT's Conservation Easement Modification Policy, complied with section 170(h) of the United States Internal Revenue Code, and were consistent with Colorado Revised Statutes sections 38-30.5-101, et seq. CCALT did not release, extinguish, or terminate any conservation easements in 2019- 2020. Our rights in a conservation easement were transferred to the co-holder of that conservation easement, consolidating responsibility to that single holder. The holder is a "qualified organization" under 170(h) of the I.R.C., and under Colorado law.

Part II, Line 5:	The Colorado Cattlemen's Agricultural Land Trust (CCALT) is currently operating under a conservation easement stewardship, monitoring, and enforcement policy originally approved by the board in 1999 and renewed in 2019. Our policies ensure that CCALT will have the financial means necessary to continue our perpetual obligations to steward the conservation easements we have and will accept going forward. CCALT's policies and procedures also ensure that CCALT will have the necessary documentation to enforce each conservation easement going forward. This includes accurate baseline files as well as proper documentation of stewardship issues which have occurred in the past. CCALT's policies and procedures ensure we are tracking changes to conserved properties and compliance with our conservation easement terms. Landowner requests or the Land Trust's response for interpretation or changes to the deed of easement must be documented in writing. Notice of the exercise of a reserved right must also be documented. If a property changes hands, it is CCALT's policy to update our records and discuss the conservation easement with the new landowner or representative to ensure that they fully understand the restrictions set forth on their property. CCALT has a policy of monitoring every easement on an annual basis. Monitoring usually includes a visit to the property in person but may also include aerial or remote monitoring. CCALT's conflict of interest policy applies to the stewardship policy and no landowner may monitor their own property. Monitors of CCALT conservation easements will not make decisions in the field as to whether or not a situation is or is not a violation of the terms of the conservation easement. Instead, monitors will collect information on the item of concern. Upper level staff will then evaluate the findings. If it is determined that a violation has occurred, a course of action is set to correct the violation. It is the stated policy of CCALT to enforce all of the terms of our conservation easements. It is the intention of the organization to avoid litigation, if possible, in the enforcement of any violation of a conservation easement. However, legal action may be required and any legal action, including the filing of injunctions, on the part of CCALT requires the adoption of a resolution of the Board of Directors.

Part II, Line 9:	The organization receives gifts of conservation easements and grants toward the purchase of conservation easements. The easements contain numerous restrictions over the use and development of land, which is not owned by the organization. The value of donated conservation easements is based on the appraised value as determined by an independent appraiser. Easements are recorded as revenue when received and an expense is recorded for an equal amount whether the conservation easement is held by the organization or transferred to an eligible entity. Grants received for the purchase of conservation easements are recorded as revenue and as a conservation easement expense when the easement is purchased. The value of easements is not reflected in the balance sheet because the easements have no economic value to the organization. The organization monitors activities on the land and enforces restrictions contained in both donated and purchased conservation easements. The organization holds 402 easements covering approximately 656,201 acres in 42 counties throughout Colorado, and in parts of Wyoming and New Mexico.

Part V, Line 4:	The Land Trust holds five endowment funds: The Stewardship Endowment Fund provides funding for the ongoing and perpetual stewardship responsibilities accepted by CCALT for the conservation easements it holds. Donations to and investment income earned on the Stewardship Endowment Fund are recorded as permanently restricted net assets until appropriated by the Board of Directors for expenditure, at which time they are released from restriction. The Operating Endowment Fund consists of a donor-established endowment in which funds could not be expended until the assets reached a specific value, which occurred during 2014. Donations to and investment income earned on the Operating Endowment Fund are recorded as permanently restricted net assets until appropriated by the Board of Directors for expenditure, at which time they are released from restriction to the general operating fund to cover a portion of the cost of ongoing Land Trust operations. The Ron and Kitty Boeddeker Peaks to Plains Conservation and Restoration Fund (the Boeddeker Fund) consists of a donor-established endowment to assist ranching families in placing conservation easements on their property. Contributions to and earnings on the Boeddeker Fund are recorded as permanently restricted net assets until appropriated by the Board of Directors for expenditure. The Land Trust is required to replenish the fund through mitigation payments and additional charitable contributions, with the understanding that the fund will contain at least \$100,000 at the end of each year. The Conservation Endowment Fund was acquired as part of the acquisition of the Yampa Valley Land Trust, Inc. and is a donor-established endowment for the purpose of supporting the completion of conservation projects. Earnings from the fund may be distributed on an annual basis. Donor restricted contributions to and investment income earned on the endowment are recorded as increases in net assets with donor restrictions until appropriated by the Board of Directors for expenditures, at which time they are released from restriction. The Rehder Ranch Endowment Fund is a donor-established endowment that consists of an investment fund and historic sheep ranch, consisting of land and buildings, acquired as part of the acquisition of the Yampa Valley Land Trust, Inc. The endowment was initially established as part of a bequest and the property is to be held in perpetuity, to be managed as a nature preserve for the study of local plants and wildlife. As part of the bequest, a cash donation was made to provide for the maintenance and upkeep of the ranch. Withdrawals are permitted from the investments held as part of the Rehder Ranch Endowment Fund when needed to provide for the maintenance and upkeep of the ranch. The current year contributions to endowment funds include \$2,904,060 in endowment assets received as a result of the acquisition of Yampa Valley Land Trust, Inc.
