The Company assumed responsibility for Westport Library book sales in February 2020. Before COVID restrictions caused the suspension of activities in mid-March 2020, the Company achieved book sales, including the sale of books on consignment on "daily sales" shelves within the Library, of \$2,887. Of these proceeds, \$659 was donated concurrently to the Westport Library

In early March 2020, the Company initiated a pilot employment program and hired three part-time employees. The objective of this program is to measure available workflow, refine defined job tasks, and evaluate resources, in order to determine the number of year-round part-time paid positions the Book Donation Center might be able to support, as well as the number of seasonal paid part-time positions that could be supported by periodic Book Sale Events. Due to restrictions resulting from the coronavirus pandemic, in mid-March 2020, the Company suspended the pilot program, just one week after its commencement. As a result of ongoing pandemic restrictions, the Company was not able to resume this program during the remainder of the fiscal year.
